## **AMNESTY FOR ILLEGALS: *The Next Thing Congress Will Shove Down Our Throats***

Right now, both the House and Senate are restarting their campaign for amnesty for more than illegal aliens—up to 20 million, by some estimates. Of course, this is being pressed forward with great urgency by President Obama and pro-amnesty advocates in his Cabinet. If amnesty is passed, those tens of millions of illegal aliens will use this country's outrageous "family re-unification act" to invite their immediate family members to join them in the United States.

This would likely include a spouse, brothers and sisters, parents, and lots of children. Thus, the real number of aliens allowed to enter the U.S. would be a multiple number—three, four, or even five times the number of illegals already here—and many would line up to immediately begin collecting welfare, Social Security, and Medicare benefits.

If amnesty is passed, this flood of immigrants would be organized within a year, prepared to use our ballot boxes to take over our country. By the time our politicians wake up to discover what their greed and stupidity have done, it will be too late to do anything. Our country will no longer be under the control of the American people. The nation that our parents put into our care will be lost forever.

President Obama has recruited a small army of high-profile, radical, pro-amnesty advocates to his Cabinet, including:

**Cecilia Munoz**, who as senior vice president at the National Council of La Raza—one of the most radical pro-illegal alien groups in the country—was in charge of this organization's entire advocacy and legislative agenda that included passing amnesty for millions of illegal aliens. Despite President Obama's pledge to restrict lobbyists from working in the Obama Administration, lobbyist waivers have been granted to, among others, Cecilia Munoz.

**John Transvina**, former president of the radical pro-illegal alien group, MALDEF (Mexican American Legal Defense and Education Fund), appointed HUD Assistant Secretary.

**Janet Napolitano**, appointed Department of Homeland Security Secretary. As former Arizona governor, Napolitano could see firsthand the devastating impact of illegal immigration and escalating violence along the border, yet she was a vocal proponent of the Senate amnesty bill. . . . Now, as Homeland Security Secretary, Napolitano is refusing to acknowledge that illegal aliens who cross the border have committed a crime, and is pushing for a dramatic shift on immigration policy.

With the Democrats possessing strong control over the House and Senate, many critical committee chairmanships have been taken over by Congressmen who support open borders and amnesty for illegal aliens.

The message is clear: If the American people do not rally to stop it, our opponents could have the numbers they need to force their amnesty bill through Congress this year.

The outrage is, American citizens are being betrayed by their own leaders.

Why else would illegal aliens have more and better access to health care than many of our own citizens? All U.S. hospitals are required to provide free health care to illegal aliens or risk losing federal funding. And now President Obama has further expanded our government's coverage of illegal aliens by a government-run health care program.

Why do illegal aliens get the low in-state tuition rates in states like California when American students from other states must pay as much as 150% of the in-state rate?

When illegal aliens hold huge rallies demanding more and more of everything, why aren't we rounding them up and deporting them? They have already identified themselves as illegal aliens.

Why did our Social Security Administration sign a treaty with Mexico that will provide Mexicans with Social Security benefits based on a work history that includes their alleged work history in Mexico? The United States Border Control group reports that the treaty has been drafted, agreed upon, and awaits only the President's signature to take effect. Some of our leaders seem to believe a world without borders would be a wonderful thing. And it might be, were it not for radical Islamic terrorists, suitcase nukes, or a deadly pandemic that could kill thousands of innocent Americans. No borders would virtually insure that millions of immigrants could overwhelm us and devastate our food supplies, our health care systems, and our entire infrastructure. Faced with our current economic crisis, the highest unemployment in 75 years, and historic, out-of-control spending by this administration, the threat from the other side of our borders becomes even more alarming.

The only way American citizens can defeat Obama's amnesty plan—which amounts to nothing less than a strategy to secure one-party control for his Party in perpetuity—is to let the politicians in Washington know that if they vote for any of these bills—*whether they pass or not*—the American people will throw them out of office, once and for all.

Pro-amnesty allies in Congress have put this dangerous policy on a fast track and are desperate to pass it as soon as possible. President Obama has joined with powerful labor unions, radical pro-illegal alien lobbying groups, and the Congressional Hispanic Caucus to create a united front to push forward amnesty this year. For the Democrat Party, the millions of illegals that could potentially become U.S. citizens "by a stroke of the pen" represents millions of votes for the Democrat Party and its increasingly radical policies.

At this point, it is difficult to gauge how soon amnesty bills will show up on the floor of the U.S. House and Senate. American citizens who understand the threat posed by amnesty for millions of illegals need to let their representatives know they are furious at Congress for even considering passage of amnesty for illegals.
