This Lawless Administration

At every turn, Barack Obama and the Democrats in power have disregarded the rule of law, the Constitution, and the will of the American people. The list of treacheries committed by this administration is stunning, and there is not sufficient space here to detail them all. We offer a few examples.

Obama Justice Department Offers Right of Trial by Jury to Enemy Combatants . . .

This current Justice Department, shortly after Barack Obama was inaugurated, unilaterally decided to try foreign enemy combatant terrorists in American federal civilian courts. It is an outrageous affront to all American citizens that politically motivated government officials took upon themselves to bestow the blood-bought constitutional right of a trial by one's peers—and all the rights that accrue to an American citizen undergoing a trial by jury—on foreign enemy combatants who hate America and attacked her in acts of terrorism.

. . . But Sues the State of Arizona

This same administration has refused to enforce the laws of our land in regard to border security and illegal alien deportation. In a blatant act of disregard for the law, they sued the State of Arizona for attempting to defend itself against an invasion of illegal aliens pouring across the border from Mexico. That move by this anti-American Obama administration has infuriated millions of American patriots.

Obama Administration Defies Court Orders on Oil Drilling . . .

On June 22, 2010, U.S. District Court Judge Martin Feldman of New Orleans blocked the six-month moratorium on deep-water drilling projects that the Obama administration had imposed in May, following the Gulf oil spill a month earlier. In his 22-page opinion, Judge Feldman issued a preliminary injunction against the enforcement of the administration's order halting all offshore exploratory drilling in more than 500 feet of water. Citing potential economic harm to businesses and workers, Judge Feldman wrote that the Obama administration had failed to justify the need for such "a blanket, generic, indeed punitive, moratorium" on deep-water oil and gas drilling.

The administration ignored Feldman's ruling, and continued to enforce its deepwater drilling moratorium, even going so far as to institute a second drilling ban in July.

The July ban was challenged by an industry lawsuit that claimed the ban was devastating the Gulf Coast economy, which is heavily dependent on deepwater drilling activities. The ban was rescinded in October, before Judge Feldman could rule on its validity.

After the administration claimed to have lifted its blanket ban in October, it failed to issue a single permit during the six months that followed, blaming strained resources and new regulations. Enesco, an offshore driller whose permits have been "under review" for as long as nine months, believes (as does Judge Feldman) that the "government's

continuous delays are intentional,” part of an effort to use last year’s BP oil spill as an excuse to limit fossil fuel extraction.

On February 2, 2011, Feldman ruled Interior Secretary Ken Salazar in contempt for imposing a second moratorium after the first had been struck down, noting that such action showed a “flagrant” disregard for the first ruling.

. . . Yet Plans to Fund Offshore Drilling in Brazil

In a shameless display of hypocrisy, President Obama addressed the Brazilian people on March 22 while vacationing in Rio de Janeiro, urging them to drill for oil off their coastline. Never mind the “hazards to the environment” that radical environmentalists scream about every time we propose drilling off *our* shores in order to reduce our dependence on foreign oil.

Obama assured the Brazilians, “We want to help you with the technology and support to develop these oil reserves safely. And when you’re ready to start selling, we want to be one of your best customers.”

Bottom line: Roughly 20,000 Americans are unemployed as a direct result of the policies and actions of the regime in Washington that despises fossil fuels as a “threat to the environment.”

With U.S. oil production sharply down, and oil prices skyrocketing, President Obama plans to send American tax dollars--to the tune of \$2 billion or more--to help the Brazilian economy create jobs for Brazilian workers! *The Wall Street Journal* reported in August 2009 that the U.S. Export-Import Bank stated it had issued a “preliminary commitment” letter to Petrobras in the amount of \$2 billion and had discussed with Brazil the possibility of increasing that amount (“Obama Underwrites Offshore Drilling,” WSJ, 8/18/2009).

Obama Administration: Guilty of Economic Sabotage . . . or “Misguided Policy”?

On March 21, 2011, Cybercast News Service reported that at least 13,000 jobs have been lost since last summer’s moratorium on offshore oil production, surpassing projected job losses in a 2010 study by thousands. The study is entitled, “The Economic Cost of a Moratorium on Offshore Oil and Gas Exploration to the Gulf Region,” and was authored by Joseph Mason, a Louisiana State University Professor. Mason estimated that the new *regional* (emphasis added) job losses due to the moratorium on offshore oil production in the Gulf region is now 13,000--up from his original estimate of 8,000.

Heritage Foundation reported on that same study, noting that Mason has estimated *national* job losses at 19,000 from the drilling moratorium, with wage losses at \$1.1 billion. That is not just Louisiana: about one-third of those jobs (vendors and industries that supply equipment and supplies to oil drilling companies) are located outside the Gulf region (Heritage Foundation, March 25, 2011).

The Obama Administration’s deliberately slow pace of issuing new drilling permits for the Gulf of Mexico has led to a sharp decline in oil production for the Gulf of Mexico this year.

Obama’s Secret Stash to Guarantee Implementation of ObamaCare

This regime has ignored two rulings that have found the notorious ObamaCare bill unconstitutional, and have gone forward with the process of implementing it. But it’s even worse than that. While ObamaCare has been perceived widely as a fiscal nightmare, it was not known until February this year how massively the bill transferred power from Congress to the Executive branch. Deeply buried in the law passed in March 2010 is a \$105-billion slush fund that assures funding into the future, no matter what future voters think or want. In February, the Congressional Research Service (CRS) updated an October 2010 report entitled, “Appropriations and Fund Transfers in the Patient Protection and Affordable Care Act.” The new report stated that, unbeknownst to almost every member of Congress, ObamaCare contains \$105 billion in direct implementation spending that bypasses Congress’s normal appropriations process.

We believe this stealth funding amounts to lawlessness. Because no one had had opportunity to read the bill and know what was in it, it is hard to see how this stealth funding could possibly be considered legal. Years’ worth of spending decisions were built into the ObamaCare bill in secret, thereby handcuffing the current Congress and preventing it from determining current levels of spending. The \$105 billion is not a budget projection, but an actual appropriation of money, enacted into law by the Democrats when they passed the bill. In order to actually defund ObamaCare, conservative lawmakers must go through all 2,700 pages of the bill and cut spending for every program, one by one.

Obama’s Justice Department Says It Won’t Defend DOMA . . .

In February, the Justice Department announced that it would no longer defend the federal Defense of Marriage Act (DOMA) because the president and Attorney General, Eric Holder, believe the law is unconstitutional. Members of the House of Representatives responded by saying they will make sure the constitutionality of the law is decided by the courts--and not by the president.

When DOMA was signed into law by President Clinton, it became the law of the land. Neither the Justice Department nor the President has the authority to declare any law invalid or unilaterally decide that a given law will not be defended in court based on personal biases of members of the Justice or Executive branches of government.

... But DOJ Dismissed the Case Against Black Panthers

On Election Day in November 2008, members of the Black Panthers, a militant black political party, brandished nightsticks and intimidated voters at a Philadelphia polling place--clearly a blatant violation of Federal Election Law. In a stunning manifestation of injustice and disregard for the rule of law--which that branch of government is chartered to uphold--U.S. Attorney General Eric Holder inexplicably chose not to prosecute the case. This, despite the fact that it was an open-and-shut case involving violations of federal law.

Obama and Socialist Facilitators Have Planted a "Debt Bomb"

Mark Alexander, publisher of *The Patriot Post*, wrote recently: "However discomfoting this fact might be, there is abundant and irrefutable evidence that Barack Hussein Obama and his socialist cadre are endeavoring to "fundamentally transform the United States of America" by planting a debt bomb, the future shockwave of which, they surmise, will break the back of free enterprise. From the ashes of that cataclysm, Obama and his ilk envision restructuring our nation as the USSA [Union of Socialist States of America]." It is probably not necessary to go into great detail here about Obama's so-called "economic recovery plan"--the federal budget forecast for the current fiscal year which includes a historic \$1.65 trillion deficit. Readers are aware that the economic consequences of unfunded government spending (meaning, we have to *borrow* the money to continue the wildly out-of-control spending by Congress), will be double-digit inflation, loss of confidence in the U.S. dollar around the world, and a monetary crisis of a magnitude never before seen in this nation's history. The only accurate way to characterize such deliberate economic destruction is *lawless*.

In February alone, the Obama government accrued a record \$223 billion deficit for one month. That single-month deficit exceeds the entire 2007 budget deficit under George W. Bush.

Congress is borrowing 40 cents of every dollar it spends, and our national debt now stands at \$14 trillion, which is roughly 97 percent of our nation's gross domestic product in 2010. As stated earlier, detailing the full extent of this administration's lawlessness would take far more space than is available here. However, a couple of other issues cited by Thomas Sowell

deserve mention: "[Obama] has by-passed the Constitution by appointing power-wielding 'czars' who don't have to be confirmed by the Senate like Cabinet members, and now he has by-passed Congress by taking military actions based on authorization by the United Nations and the Arab League." ("Measuring Force," *TownHall.com*, 3/30/2011) Sowell's words state concisely the utter contempt that Barack Obama feels for the authority of the United States Congress--*one of the three coequal branches of government established by the Constitution*. He has arrogantly bypassed that branch, referring to work his will through his czars, the United Nations, and the Arab League!

A Time of Choosing

Alan Greenspan, former chairman of the Federal Reserve, concluded that "*Deficit spending is simply a scheme for the hidden confiscation of wealth.*" Russian dissident Alexander Solzhenitsyn wrote, "*Socialism of any type leads to a total destruction of the human spirit.*" Barack Obama is a radical leftist, blinded by disdain for America, which he chooses to see through the distorted lens of Marxism and years of indoctrination by socialist mentors and radical, leftist ideologues such as Frank Marshall Davis and Saul Alinsky. It is beyond shocking for many Americans to realize that the President of the United States sees it as his mission to dismantle capitalism--which has made America the most prosperous and generous nation in history--and obliterate the foundations that have made America a nation of exceptional opportunity and freedom.
